The petitioner who apprehends arrest at the hands of the respondent Police for the offences punishable under Sections 294(b), 353, 506(ii) of IPC and Section 3(1) of PPD Act 1984 @ 120(B), 294(b), 328, 353, 506(ii) of IPC r/w Section 8(c), 20(b)(ii)(B) of NDPS Act and Section 3 of PPD Act in Crime No.514 of 2022, seeks anticipatory bail.

2.The case of the prosecution is that while the respondent Police and his team were on routine rounds, they found that the petitioner along with other accused was found in illegal possession of 6 kilograms of Ganja. Hence the complaint.

3. The learned counsel for the petitioner would submit that the petitioner is an innocent person and based on the confession statement recorded from A1, he has been falsely implicated in this case. He would further submit that the co-accused in this case has already been enlarged on bail. Hence, he prays for grant of anticipatory bail to the petitioner.

4.The learned Government Advocate (Crl.Side) appearing for the respondent would submit that the petitioner along with other accused was found in illegal possession of 6 kilograms of Ganja. He would submit that there is no previous case pending against him. Hence, he opposed for grant of anticipatory bail to the petitioner.

5.In reply, the learned counsel for the petitioner would submit that without prejudice, the petitioner is ready and willing to pay a sum of Rs.15,000/- to any Charitable Institute as may be directed by this Court and he would pray for grant of anticipatory bail to the petitioner.

6.Heard the learned counsel for the petitioner and the learned Government Advocate (Crl.Side) for the respondent and perused the materials available on record.

7.Considering the facts and circumstances of the case and also

the submissions made by the learned counsel for the petitioner and that the investigation has been completed, this court is inclined to grant anticipatory bail to the petitioner with certain conditions.

8.Accordingly, the petitioner is directed to deposit a sum of **Rs.15,000/- (Rupees Ten Thousand only) to the Society for the Educational and Economic Development (SEED) Reg., Sriperumbudur, A/c.Name: SEED, A/c.No. 2926101000002, Canara Bank, Sriperumbudur, IFSC Code: CNRB0002926** and on such receipt and receipt of proof of payment, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned Judicial Magistrate, Tiruttani, on condition that the petitioner shall execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the respondent police or the police officer, who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a]the petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

(b) the petitioner shall report before the respondent police station on alternative days at 10.30 a.m., for a period of three months;

(c)the petitioner shall not tamper with evidence or witness either during investigation or trial;

(d)the petitioner shall not abscond either during investigation or trial;

(e) on breach of any of the aforesaid conditions, the learned Magistrate/ Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in ***P.K.Shaji Vs. State of Kerala [(2005) AIR SCW 5560]***; and;

(f)if the accused thereafter absconds, a fresh
