ORDER

The grievance of the petitioner in this writ petition is that he was not allowed to take the assistance of a retired employee in the disciplinary proceedings initiated against him by the respondents.

The learned Additional Government Pleader appearing for the respondents has placed before this Court the Proceedings of the 2nd respondent dated 26.12.2022 under which, it has been made clear that the petitioner can seek the assistance of a retired employee in the disciplinary proceedings initiated against him. It is also mentioned in the Proceedings dated 26.12.2022 that the documents sought for by the petitioner has also been furnished to the petitioner. Since the grievance of the petitioner has been redressed as seen from the Proceedings of the 2nd respondent dated 26.12.2022 which is placed on record, this writ petition is disposed of by recording the said Proceedings, wherein, the respondent has agreed for the petitioner to take the assistance of a retired employee in the disciplinary proceedings initiated against him.
