ORDER

This writ petition has been filed seeking for a limited relief.

2. The petitioners seek for early disposal of their petition filed before the 4th respondent seeking for conferment of permanent status as per the provisions of the Tamil Nadu Industrial Establishments (Conferment of Permanent Status to Workman) Act, 1981. The petitioners have filed the said petition on 18.08.2022.

3. Mr.S. Haroon Al Rasheed, learned counsel who has accepted notice on behalf of the respondents 1 to 3 would submit that the petition filed by the petitioners seeking for conferment of permanent status is not maintainable.

4. This Court is not expressing any opinion on the merits of the respective contentions. It is for the 4th respondent to consider the same on

7. With the aforesaid directions, this writ petition is disposed of.
