WEB COPY This Criminal Original Petition has been filed to quash the Charge Sheet in C.C.No.1359 of 2022 on the file of the learned Metropolitan Magistrate No.XVI, George Town at Chennai.

2.Today, when the matter is taken up for hearing, the learned counsel for the petitioners submitted that there is a delay in filing the final report.
