On receipt of the same, the 2nd respondent would do the needful to dispose of the said representation dated 07.11.2022 within a time frame that may be stipulated by this Court.

4. Considering the said submissions made by the learned Government Advocate, this Court is inclined to dispose of this writ petition with the following order.

“That there shall be a direction to the petitioner to forward a copy of the representation dated 07.11.2022 to the 2nd respondent Tahsildar, who on receipt of the same, shall consider theon merits and in accordance with law and pass orders within a period of six weeks from the date of receipt of a copy of this order.”

5. With the above directions, this writ petition is disposed of. No costs.
