2.It is the contention of the learned counsel for the petitioners that petitioners are running a business of Massage Parlour, SPA, Beauty Parlour in the name and style of “Silver Spa” and “Chillum Wellness Care”. He would further submit that the petitioner has made a representation dated 18.11.2022 to the respondents seeking for the issuance of “No Objection Certificate” to run the said business and the same is not considered by the respondents. Hence the petition.

3.The learned Government Advocate (Crl.Side), appearing for the respondents submitted that the respondent police has received the representation of the petitioners and the same is pending for consideration.
