2.The respondents 2, 3 & 4 are senior citizens and they have issued authorization letters dated 08.09.2023, authorizing one Mr.K.N.K.Suresh, who is the son of second respondent herein. He had also produced a proof of his identity and other respondents are present before us.

3. Recording the above agreement between the parties, this Writ Petition is disposed of in terms of the above settlement. No cost. Consequently, connected miscellaneous petition is closed.
