- (1)The present writ petition has been filed by the petitioner seeking a mandamus to direct the respondents to grant 30 days Ordinary leave to without escort to the father of petitioner/convict namely Mr.Mari, convict No.7427.
- (2)The father of the petitioner herein is a convict prisoner. The petitioner, son of the detenu has submitted a representation dated 10.11.2023 seeking 30 days ordinary leave for his father without escort.
- (3)The learned Additional Public Prosecutor on instructions, submitted that the said representation would be considered on merits after obtaining the Reports from the Probation Officer and the Police.
- (4)In the said circumstances, this Court is of the view that this writ petition can be disposed of by issuing a direction to the respondents.
