## ORDER

2. Having regard to the nature of order proposed to be passed in the Writ Petition, which would not cause any prejudice to the Third to Fifth Respondents, notice to them are dispensed with.

The grievance ventilated by the Petitioner is that he had made a representation dated 22.09.2019 followed by reminders dated 13.01.2023, 04.03.2023 and 01.08.2023 to the First Respondent for regularization of plot, but as it did not evoke any response, it has necessitated the filing of this Writ Petition.
