4. In view of the above submission, the grievance of the petitioner has been redressed and therefore, no further orders are required to be passed in this writ petition. The petitioner is granted liberty to upload her application in the on-line portal of the third respondent herein and the third respondent shall ensure that the petitioner's application is accepted by them and subject the application to further selection process.

5. With the above observation, the writ petition is closed. No costs. Consequently, connected miscellaneous petition is closed.
