ORDER

Heard Ms.V.Shri Varshini, learned counsel appearing for Mr.I.Abrar Md Abdullah, learned counsel for the petitioner, Mrs.R.Anitha, learned Special Government Pleader for respondents 1 to 3 and 5 and Mr.P.Muthukumar, learned State Government Pleader for respondent 4.

2. Learned counsel for the petitioner submits that in the year 2015 itself, the Tahsildar has stated that notice under Section 7 of the Tamil Nadu Land Encroachment Act, 1905 has been issued to remove the encroachers on all the encroachments including the patta holders in S.Nos.150, 151/1 and 161/9, however, till date, no action has been taken.

3. Learned State Government Pleader, on instructions, submits that fresh inspection would be done within a period of four weeks from today and depending upon the report of the inspection, if encroachments are found, further steps would be initiated within a period of four weeks thereafter.
