The Petitioners seek anticipatory bail in Crime No.527 of 2023 registered by the respondent police for the offences under Sections 147, 148, 294(b), 323, 447, 427, 506(ii) and 379 IPC.

2. The learned Government Advocate (Criminal Side) stated that the petitioners and the defacto complainant are neighbours and there is also a civil suit between them which is now pending in A.S.No.31 of 2023 on the file of the Sub Court at Tiruvannamalai. He stated that there was a dispute relating to removal of the fence which escalated into violence.

3. The learned counsel for the Petitioners stated that the Petitioners were not involved in any of the offences as stated by the respondent police. Thus, he prays for anticipatory bail to the Petitioners herein.

4. Taking all the factors into consideration, this Court is inclined to grant anticipatory bail to the Petitioners with certain conditions. Accordingly, the petitioners are ordered to be released on bail in the event of arrest or on

their appearance, within a period of fifteen days from the date on which the order copy made ready, before **the Judicial Magistrate No.II, Tiruvannamalai**, on condition that the petitioners shall execute a separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a] the petitioners and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioners shall report before the Respondent Police daily at 10.30 a.m., for a period of two weeks and thereafter, as and when required for the interrogation.

[c] the petitioners shall not tamper with evidence or witness either during investigation or trial.

[d] the petitioners shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
