2. The Petitioner has sought for a direction to the First Respondent to dispose his appeal dated 03.02.2023 seeking certain information under the Right to Information Act, 2005.

3. Learned Government Advocate appearing for the Respondents, on instructions, states that the information sought by the Petitioner has been furnished to him and the Second Respondent has filed a memo dated 21.12.2023 to that effect, which is placed on record.
