ORDER

The petitioner who was arrested and remanded to judicial custody
on 25.11.2023 for the offences punishable under **Sections 341, 294(b), 323,**

392, 397 and 506(2) of I.P.C in Crime No.1192 of 2023 on the file of the respondent Police, seeks bail.

2. The case of the prosecution is that the petitioner along with other accused waylaid the victim at knife point and robbed a sum of Rs.350/- from him and also threatened him with dire consequences. Hence the case.

3.The learned counsel for the petitioner submitted that the petitioner is an innocent person and he has been falsely implicated in this case. He further submitted that the petitioner has been in judicial custody from 25.11.2023 and hence, he seeks for granting of bail to the petitioner.

4.The learned Additional Public Prosecutor for the respondent submitted that the petitioner along with other accused waylaid the victim at knife point and robbed a sum of Rs.350/- from him and also threatened the defacto complainant with dire consequences. She would further submit that there are seven previous cases pending against the petitioner. Hence, she opposed for grant of bail to the petitioner.

5. Heard both side and perused the materials available on record.

6. Considering the rival submissions made on either side and taking into consideration the period of incarceration undergone by the petitioner and **also taking note of the nature of offence charged against the petitioner**, I am inclined to grant bail to the petitioner, subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned **Judicial Magistrate at Ambattur** and on further conditions that:

[b] the petitioner shall report before the respondent police everyday at 10.a.m., until further orders.

[c] the petitioner shall not commit any offences of similar nature.

[d] the petitioner shall not abscond either during investigation or trial.

[e] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of
