The petitioner who apprehend arrest at the hands of the respondent police for the offences punishable under Sections 294(b), 324 & 506 (ii) of IPC in Crime No.920 of 2023, seeks anticipatory bail.

2. The case of the prosecution is that the petitioner and the defacto complainant are friends. The petitioner hit the defacto complainant with beer bottle and tried to extort money from the defacto complainant. Hence, the complaint.

3. The learned counsel for the petitioners would contend that they are falsely implicated by the respondent police in the case and also submitted that the injured sustained only simple injuries and the defacto complainant is discharged from hospital, hence he seek anticipatory bail.

4. The learned Government Advocate (Crl.Side) would submit that the petitioner attacked the defacto complainant and caused injuries. He would further submit that the injured has been discharged from the

hospital. However, he vehemently opposed to grant anticipatory bail to the petitioner.

5. Considering the rival submissions on either side and considering the fact that the injured sustained only simple injuries, and the defacto complainant is discharged from hospital and also considering the fact that except 506(ii) of IPC other offences are bailable in nature, this Court is inclined to grant anticipatory bail to the petitioner, subject to the following conditions:

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on their appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned Judicial Magistrate, Ambattur, Tiruvallur District, on condition that the petitioner shall execute a separate bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a] the petitioner and the sureties shall affix their photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of their Aadhar card or Bank pass Book to ensure their identity.

[b] the petitioner shall report before the respondent police daily at 10.30 a.m., for a period of thirty days and thereafter as and when required for interrogation.

[c] the petitioner shall not tamper with evidence or witness either during investigation or trial.

[d] the petitioner shall not abscond either during investigation or trial.

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**.

[f] If the accused thereafter abscond, a fresh FIR can be registered under Section 229A IPC.
