ORDER

The petitioner/Accused, who was arrested and remanded to judicial custody on 29.11.2023 for the offences under sections 341, 294(b), 392, 397 and 506(2) of IPC in Crime No. 432 of 2023 on the file of M-8, Santhangadu Police Station, Thiruvallur District, seeks bail.

2.The learned counsel appearing for the petitioner would contend that the petitioner is in custody for more than 25 days and he has not committed any offence as alleged in FIR. Hence, he prayed to grant bail to the petitioner.

3.The learned Additional Public Prosecutor appearing for the respondent police would contend that the petitioner at knife point robbed Rs.1,000/- from the defacto complainant's shop and also used filthy languages. The Additional Public Prosecutor would further submit that there are thirteen previous cases against the petitioner and the offences are grave in nature. If the petitioner released on bail, it will affect the investigation and thereby, she strongly opposed to grant bail to the

petitioner.

4.Heard both sides and perused the materials available on record including the First Information Report.

5.Considering the submissions made on either side, considering the period of incarceration and also the fact that the petitioner has been granted bail in other cases and considering the nature of offences, this court is inclined to grant bail to the petitioner subject to the following conditions:

[a] Accordingly, the petitioner is ordered to be released on bail on condition to execute a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate, Thiruvottiur and on further conditions that:

[b] the petitioner shall report before respondent police daily at 10.00 A.M., until further orders.
