When the matter is taken up, learned Special Government Pleader for the petitioner sought permission of this Court to withdraw the tax case and a memo for withdrawal dated 06.01.2023 has also been filed, which reads thus:

"1. The above Tax Case Revision was filed by the Department against the orders passed in STA No.390 of 2007 without full set of papers viz. 2nd set, delay affidavit and petition, delay in representation, batta, typed set, coding sheet, verified petition etc. and the same was returned by the Registry vide T.C.SR. NO. 80081 of 2014.

2. In the meantime, the orders passed in STA No.390 of 2007 has been accepted by the Commissioner of Commercial Taxes/covered under litigation policy. Therefore, the Department has not represented the Tax Case Revision within the time stipulated by the Registry.
