When the matter is taken up, learned Special Government Pleader for the petitioner sought permission of this Court to withdraw the tax case and a memo for withdrawal dated 06.01.2023 has also been filed, which reads thus:

*"1. The above Tax Case Revision was filed by the Department against the orders passed in STA No.625 of 2015 without full set of papers viz. 2<sup>nd</sup> set, delay affidavit and petition, delay in representation, batta, typed set, coding sheet, verified petition etc. and the same was returned by the Registry vide T.C.SR. NO. 56970 of 2016.*

*2. In the meantime, the orders passed in STA No.625 of 2015 has been accepted by the Commissioner of Commercial Taxes/covered under litigation policy. Therefore, the Department has not represented the Tax Case Revision within the time stipulated by the Registry.*
