After mutual discussion, negotiation, mediation and conciliation between both parties, they arrived at a compromise to settle the matter as

TERMS OF SETTLEMENT

Both the learned counsel on record along with their respective parties are present. Today, when the matter was taken up for settlement, it is reported by both sides that totally there are three cases pending against the respondent/accused and that in all the three cases, both the parties have arrived at a settlement and they have filed a Joint Compromise Memo, dated 09.09.2023.

2. In this case, as per the Joint Compromise Memo, the Appellant/Complainant has agreed to receive a sum of Rs.1,00,000/- [Rupees One Lakh only] in full quit in respect of this case in C.C.No.16 of 2012 on the file of the Judicial Magistrate Court (FTC), Vellore.

3. It is stated that already a sum of Rs.1,00,000/- has been deposited by the respondent/accused to the credit of C.A.No.46 of 2015 on the file of the Principal District and Sessions Court, Vellore and the same may be permitted to be withdrawn by the appellant/complainant from the credit of the above said account without any notice to the respondent/accused. The Joint Compromise Memo is recorded and the same shall form part of this award.

4. This Criminal Appeal is disposed of in terms of Joint
