Prayer in W.P.No.32104 of 2018: Writ Petition filed under Article 226 of the Constitution of India, to issue an order or writ, more in the nature of a Writ of Certiorarified Mandamus, calling for records in and connected with Notification No.22/2015-20 dated 21.08.2017 & Notification No.6/2015-20 dated 04.05.2018 read with Trade Notice No.19/2018 dated 25.10.2017 and Table Notice No.06/2018-19 dated 11.05.2018 attributable to the 1st and 2nd respondents and quash the same and further direct the 3rd respondent to permit clearance of 2000 MTS of Green Mung Beans falling under Exim Code 0713 3100 in terms of Sales Contract No.SW/73/2018-19 dated 26.11.2018.

Prayer in W.P.No.32111 of 2018: Writ Petition filed under Article 226 of the Constitution of India, to issue an order or writ, more in the nature of a Writ of Certiorarified Mandamus, calling for records in and connected with Notification No.19/2015-2020 dated 05.08.2017 read with Trade Notice No.06/2018-19 dated 11.05.2018 attributable to the 1st and 2nd respondents and quash the same and further direct the 3rd respondent to permit clearance of about 2500 MTS of Pigeon Peas falling under Exim Code 0713 6000 in terms of Sales Contract No.SW/74/2018-19 dated 26.11.2018.
