ORDER

It is open to the workman as well as the Management, to raise all issues including those raised in the present writ petition, before the Central Government Industrial Tribunal. The Central Government Industrial Tribunal, is requested to take up the matter and dispose of the same, as expeditiously as possible, within a period of nine months, from the date of receipt of a
