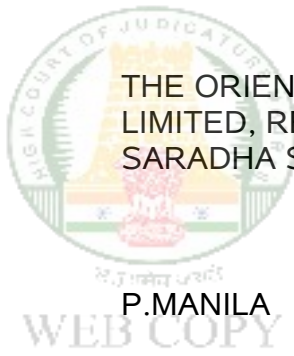

This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.Jawahar Ravindran and the counsel for the respondent/s Mr.N.Palanisamy are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both parties are present and they accepted for the award Rs.18,25,000/- passed by the Tribunal and also the respondents 1 to 3 are accepted to deduct the sum of Rs.1,00,000/- from interest. The appellant is permitted to withdraw this Appeal. The 50% amount has already deposited and withdrawn and remaining 50% of the award amount and interest to be deposited within two weeks from the date of petition before the lower Court. After depositing the amount, the parties can withdraw the amount immediately as per the Lower Court decree. Consequently, the connected miscellaneous petitions are closed.
