AWARD

This Civil Miscellaneous Appeal is filed by the appellant / Insurance Company against the award dated 27/02/2007 in M.C.O.P.16/2005 on the file of the Sub Judge, Pudukottai.

Now, the appellant / Insurance Company is willing to withdraw the appeal and undertakes to deposit the award amount fixed by the Tribunal within a period of eight weeks.

In view of the above submission, this Appeal is dismissed as withdrawn. The order of the Tribunal is confirmed. As per the order of the Tribunal, the appellant / Insurance Company is directed to deposit the

entire award with 7.5% interest and costs, within a period of eight weeks from the date of receipt of this award, less the amount already deposited, if any. On such deposit being made, the claimants are entitled to withdraw their respective share amount without filing any formal permission petition.
