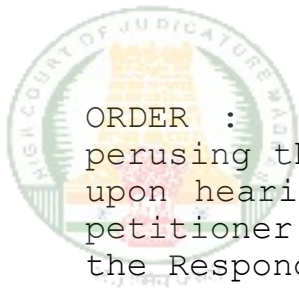
Petition filed praying that in the circumstances stated therein
