ORDER

Thoothukudi District TNSSTC Employees Union, Tirunelveli. The said Association was founded in the year 1998, to safeguard the welfare of the transport employees. The third respondent has insulted the labours, calling them in a singular manner without considering their age and used offending words to cause great distress. Hence, the petitioner Association made a representation to the respondents 1 and 2, on 23.12.2022. Since the said respondent has not been considered, the petitioner has filed the present writ petition.

3. Since no adverse order is going to be passed as against the respondents 3 and 4, notice to the respondents 3 and 4 is dispensed with.

4. Heard the learned counsel for the petitioner and the learned counsel appearing for the respondents 1 and 2.

5. Considering the limited request made by the learned counsel for the petitioner, this Court directs the first respondent to consider the representation of the petitioner dated 23.12.2022 and pass appropriate

orders, after affording opportunity to the respondents 3 and 4, within a period of twelve weeks from the date of receipt of a copy of this order.
