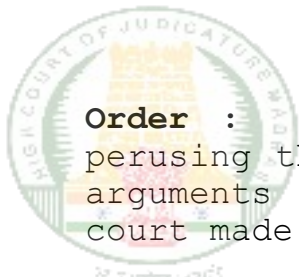
Prayer in CRL MP(MD) . 163/ 2020 :
