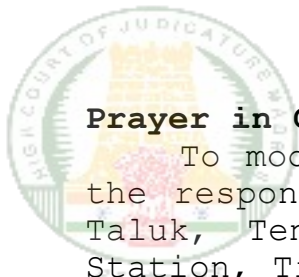

This Petition has been filed to relax the condition imposed in Crl.M.P.(MD)No.15408 of 2022 in Crl.O.P(MD)No.18770 of 2022, dated 12.12.2022.

2.The learned Counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (crl.side) appearing for the respondent would submit that the petitioners have been complying with the conditions.

4.Considering the said submission, the condition imposed by this Court in Crl.M.P.(MD)No.15408 of 2022 in Crl.O.P(MD)No.18770 of 2022, dated 12.12.2022 is modified to the effect that the petitioners 8 and 10 shall report before the respondent police as and when required and the other petitioners shall report before the Inspector of Police, Tirunelveli Town Police Station, Tirunelveli on the first Saturday of every English Calender month at 10.30 am until further orders.

5.With the above direction, this Criminal Miscellaneous Petition is ordered.
