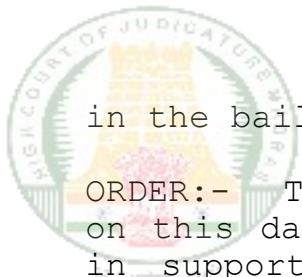
Prayer in CRL MP(MD). No.497 of 2023:-

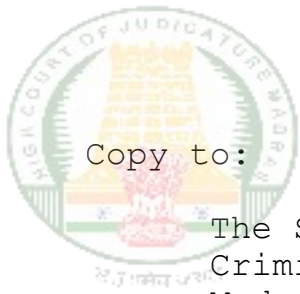
