ORDER

This criminal original petition has been filed seeking a direction to the second respondent to discontinue the harassment, humiliation on the petitioners forthwith.

2.The learned Counsel appearing for the petitioners would submit that the father of the petitioners 1 and 3 and the third respondent entered into an agreement for making constructions that the father of the petitioners 1 and 3 died due to COVID and that now, the third respondent has lodged a complaint as if the first and third petitioners' father has not repaid the amount of Rs. 3,00,000/-.

3.The learned Government Advocate(Crl.Side) would submit that on the basis of the complaint given by the third respondent, enquiry is pending.
