2.The learned Counsel appearing for the petitioner would submit that the petitioner is the owner of the property and the third respondent and one Anandha Ganesan, who were managing the property, have forged the signature of the petitioner and prepared a sale agreement and on that basis, they have now lodged a complaint.

3.The learned Government Advocate(Crl.Side) would submit that on the basis of the complaint given by the third respondent, enquiry was pending. He would further submit that since the dispute is civil in nature, the second
