A direction is issued to the respondents 4 and 5 to not hold the default made by the mother as against the petitioner but to grant loan on the basis of the security provided independently by the petitioner herein. Such exercise may be completed within a period of four weeks from the date of receipt of a copy of this order. No further orders are required.

3. With the above direction, the writ petition stands disposed of. No costs.
