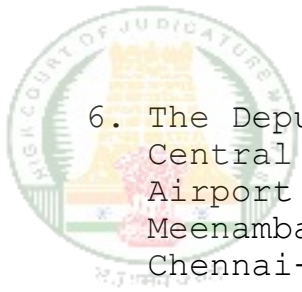

Prayer in WMP(MD).NO.752 of 2023:-

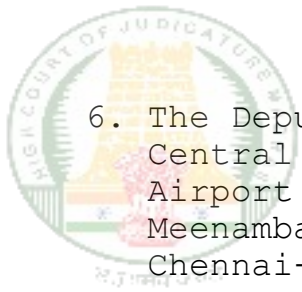
