A batch of Writ Petitions and Criminal Original Petitions are filed by the tenants in the premises owned by the fourth respondent herein alleging that the fourth respondent is attempting to illegally evict them and that they have lodged a complaint before the respondents 1 to 3 and no action has been taken by them. The Writ Petitions are filed seeking a writ of Mandamus directing the respondents to take action on those complaints. The Criminal Original Petitions have been filed by the tenants seeking direction to register and investigate their complaints.

2. The learned counsel for the petitioners in all the petitions submitted that the dispute between the landlord and the tenants has been now settled and
