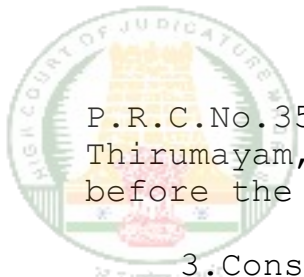
Prayer in CRL MP(MD)No. 766/ 2023 :
