2. The third respondent, Tahsildar, Aranthangi Taluk Office, Aranthangi, Pudukkottai District has filed a counter on 14.02.2020 wherein, in paragraph no.6, it is stated as follows:

*"6...Eventhough, the IA filed by the 5th respondent and the Execution Petition filed by the petitioner are all pending in the respective District Munsif Court and Sub Court, the 4th respondent has issued notice dated 08.02.2020 to the petitioner fixing the date of measurement of F.Line in respect of the boundaries of the lands in SF.Nos.36/7B, 36/7C1, 36/7C2 and 36/7C3 of Rajendrapuram Village and also to the 5th respondent and also to all other adjacent land pattadars to be present on 08.02.2020. I shall complete the measurement work and submit my compliance report."*

3. It is now reported by the learned counsel for the petitioner that the above exercise has also been completed.
