3.Considering the reasons assigned in this petition, this petition is allowed and the time is extended by two weeks from the date of receipt of a copy of this order and no further extension is permitted.

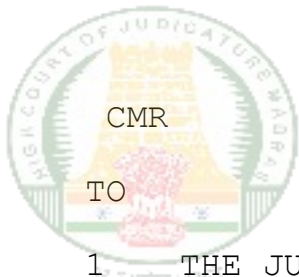
