Prayer in CRL RC(MD). 510/ 2022 :

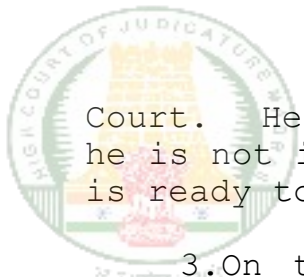

SYRESH KUMAR, Government Advocate(crl.side) on behalf of the Respondents the court made the following order:-

This petition has been filed to modify the condition imposed on the petitioner/accused by this Court in Crl.M.P.(MD).No.14393 of 2022 in Crl.R.C.(MD).No.510 of 2022 and reduce the deposit amount to a reasonable quantum.

2.The learned counsel for the petitioner submitted that a condition has been imposed upon the petitioner to deposit a sum of Rs.3,00,000/- to the credit of this crime number before the trial

Court. He would further submit that because of his incarceration, he is not in position to contact his family members. However, now he is ready to deposit Rs.2,00,000/-.

3. On the above said undertaken, this petition is allowed and the condition imposed upon the petition is modified to the effect that the petitioner shall deposit a sum of Rs.2,00,000/- (Rupees Two Lakhs only) before the trial Court to the credit of the crime number, within a period of fifteen days.
