3.The grievance of the petitioner is two fold. (a) Proper survey must be undertaken in his presence before any cart track is laid. (b) The dimensions of the cart track namely its width should not suddenly increase when it comes to his lands.

4.I find both the requests of the petitioner to be reasonable. The dimension of the cart track should be remain constant from the beginning point till the end point. Survey shall also be done. By adhering to the aforesaid two directions, cart track can be laid. The petitioner is directed to remove the fence forthwith and without delay.

5.This writ petition is disposed of accordingly. No costs. Consequently, connected miscellaneous petition is closed.
