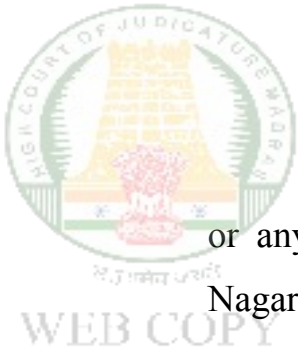

ORDER

2. Mr.E.Antony Sahaya Prabahar, learned Additional Public Prosecutor takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3. The learned Additional Public Prosecutor appearing for the respondents would submit that the accused house is situated surrounding the proposed place for holding agitation.

Recording the submissions made on either sides, the writ petitioner is directed to give a fresh representation before the second respondent indicating the proposed place and on such representation, the second respondent is directed to consider the same and pass orders within a period of three days from the date of representation.

6. With the above directions, this Writ Petition stands disposed of.
