Today, when the matter was taken up for hearing, the learned Government Advocate appearing for the respondents 1, 2 and 4 submitted that patta granted infavour of the respondents 5 and 6 has been cancelled and restored the same to its original classification and the same is now maintained by the third respondent, which is not refuted by the learned counsel appearing for the petitioner.
