PRAYER :-

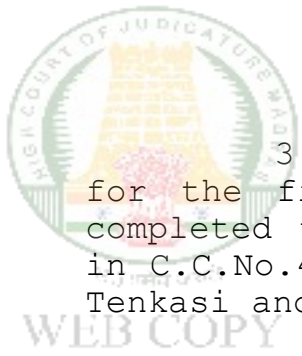
To cancel the order of anticipatory bail granted by the

On perusal of the order of the anticipatory bail granted in favour of the second respondent, there was no such condition, whereas whatever the condition imposed while granting anticipatory bail, the second respondent duly complied with the same and now the investigation has been completed and filed the final report and the same has been taken cognizance in C.C.No.4 of 2021 on the file of the learned Judicial Magistrate, Tenkasi and it is pending for trial. Hence, this Court finds no ground to cancel the bail granted to the second respondent. Accordingly, this Criminal Original Petition is dismissed.
