This Writ Petition has been filed seeking for issuance of Writ of Mandamus to direct the third and fourth respondent to provide adequate police protection while surveying the property Survey No. 363/14 to the extent of 0.00.148 hectares situated at Pitchandavar Temple, Manachanallur Taluk, Tiruchirapalli District by the first and second respondent based on the representation of the petitioner dated 02.07.2020

2. According to the petitioner he sent representation dated 02.07.2020 to the respondents for providing police protection to survey the property in dispute. The respondents 3 and 4 have not considered the representation, hence the petitioner has filed the present petition.

3. The learned Additional Public Prosecutor appearing for the respondents 1 to 4 would submit that already the representation of the petitioner was considered the same was closed.
