Prayer in WP(MD). 22688 of 2021 :-

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of MANDAMUS directing the 2nd respondent to accommodate the petitioner as Block Resource Teacher Educator in any of the nearest vacancy available in and around the Madurai or Virudhunagar District by considering the petitioners representation dated 20.11.2021 within the period that may be stipulated by this Honble Court and pass such further or other orders as this Honble Court may deem fit and proper in the circumstances of the case and thus render justice.
