This writ petitioner filed this Writ Petition seeking for issuance of a Writ of Mandamus, to direct directing the second respondent to grant permission and necessary protection to perform the cultural programme (i.e,) Adal Padal on 22.01.2023 at 07.00 pm to 10.00 pm in the evening of “Sri Madurai Veeransamy Pongal Thiruvizha” Thirumangalakottai, East Mookarai Street, Orthanadu, Thanjavur District.

2.The learned Additional Public Prosecutor. takes notice for the respondents. By consent, this writ petition is taken up for final disposal at the admission stage itself.

3.The learned counsel appearing for the petitioner submitted that “Sri Madurai Veeransamy Pongal Thiruvizha” at Thirumangalakottai, East Mookarai Street, Orthanadu, Thanjavur District, is going to be held on 22.01.2023. Subsequent to the same, in order to conduct a Adal Padal on the same day (22.01.2023), they sought permission of the police by giving a representation dated 09.01.2023. But, the second respondent has not considered the said representation. Since no order was passed, the petitioner has come before this Court for the above said relief.

It is brought to the notice of this Court that the Director General of Police, Tamil Nadu, Chennai had issued a circular memorandum in Rc.007301/Genl.I (1)/2019, dated 09.04.2019, along with instructions to the Inspectors of Police throughout Tamil Nadu for consideration of applications seeking permission for conducting cultural programme. Therefore, in view of the detailed circular and guidelines issued by the Director General of Police, the second respondent police is hereby directed to consider the representation of the petitioner, dated 09.01.2023 and pass suitable orders based on the above said circular.
