2. The learned counsel appearing for the petitioner would submit that there existed property dispute between the petitioner and the respondents 3 to 5.

3. Admittedly, there is no enforceable decree or order from the competent civil Court.

4. The learned Government Advocate (Criminal Side) appearing for the respondents 1 and 2 would submit that on the basis of the complaint given by the petitioner against the respondents 3 and 4,

enquiry was conducted and at that time, the petitioner and the respondents 3 and 4 have given statements dated 24.09.2022 to the second respondent stating that they will approach the competent civil Court and as such, no further action is necessary, recording the same, the complaint was ordered to be closed.
