PRAYER : Writ Petition is filed under Article 226 of the Constitution of India praying to issue a Writ of Mandamus directing the respondents to conduct survey and fix the four boundaries of the petitioner's patta land in S.F.No.134/9F, with an extent of 0.12.0 ares situated in Ariyanipatti Revenue Village, Gandharvakottai Taluk, Pudukkottai District.

ORDER

The petitioner seeks a survey of his patta lands at S.F.No. 134/9F measuring 0.12.0 Ares at Aranyanipatti Revenue Village, Kandarakottai Taluk, Pudukottai District. Adjacent to the lands of the petitioner, there is a Cart track.

2. It is complained that the respondents tried to put up a cart-track, even in the patta land of the petitioner herein. Therefore, the petitioner had given an application seeking survey of his lands.

3. The respondents are directed to survey the lands of the petitioner, but the cart-track should remain as before and that cannot be obliterated because it will be useful for the general public. Leaving out the cart track, the lands of the petitioner may be surveyed. If there is a policy decision taken to widen the cart-track, then, necessary steps may

be taken by the respondents, in accordance with the procedure established by law.

4. With the above directions, the writ petition stands disposed of. No costs.
