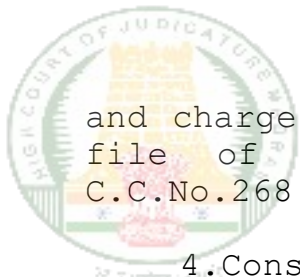

This Petition has been filed to relax the condition imposed in Crl.O.P(MD).No.19279 of 2022, dated 01.11.2022.

2.The learned Counsel for the petitioners would submit that the petitioners have been complying with the conditions regularly and hence, he seeks for relaxation of the condition.

3.The learned Government Advocate (crl.side) appearing for the respondent would submit that the investigation has been completed



and charge sheet has been filed and the case has been taken up for file of the learned Judicial Magistrate, Cheranmahadevi, in C.C.No.268 of 2022 and the case stands listed on 24.02.2023.

4.Considering the said submission, the condition imposed by this Court in Crl.O.P(MD).No.19279 of 2022, dated 01.11.2022 is modified to the effect that the petitioner shall appear before the learned Judicial Magistrate, Cheranmahadevi, on 24.02.2023 and thereafter, on the dates fixed by the learned Trial Judge.
