After mutual discussion, negotiation, mediation and conciliation between both parties and

with the assistance of the Bench, both sides consented for settlement.

### **AWARD**

Today, both the parties are agreed to resolve their issues as per the following terms.

2. The claimant/first respondent herein agreed to receive a sum of Rs. 4,25,000/- (Rupees Four lakhs and Twenty Five Thousand only) with interest at the rate of 7.5% from the date of petition till the date of deposit. The appellant/Insurance Company informed the Court that a sum of Rs.2,78,400/- has already been deposited. Hence, the appellant/Insurance Company shall deposit the balance amount of Rs.1,46,600/- with interest and cost within a period of six weeks from the date of receipt of a copy of this order. On such deposit being made, the first respondent/claimant is entitled to withdraw the entire award amount without filing any formal application before the tribunal.
