Prayer in CRL MP(MD). No.1316 of 2023:-

This Criminal Appeal has been filed under Section 14(A) (2) SC/ST (POA) Act, to call for the records relating to the impugned order dated 09.12.2022 made in Cr.M.P.No.1149 of 2022 on the file of the learned Sessions Judge, Special Court for Trial of Cases registered under SC/ST (PoA) Act, 1989, Ramanathapuram, and to set aside the same and consequently to release the appellant on bail in connection with the FIR in Crime No.246 of 2022 on the file of the second respondent Police.
