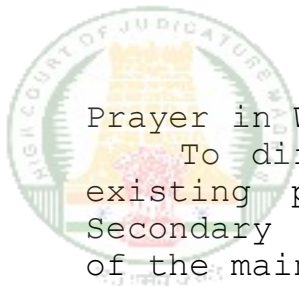

To issue a Writ of Certiorarified Mandamus, calling for the records related to the impugned proceedings of the 4th respondent in Na.Ka.No. 1137/18651/2019 dated 29.12.2022 and the consequential order passed by the 5th respondent in W.P. 1224/703/2022 dated 30.12.2022 and quash them both as illegal and issue a consequential direction to the respondents to reinstate the petitioner in the post of Cook at Government Tribal Residential Higher Secondary School, Manalodai, Kanyakumari District with back wages, continuity of service and all other attendant and consequential service, monetary and other benefits within the time stipulated by this Court.

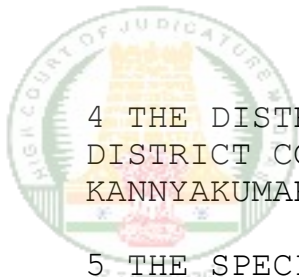
